MEDICAL SERVICES	The Local Organizing Committee will provide a first medical aid service, a doctor and emergency medical transportation in the competition area.		
COVID-19	The LOC should follow local guidelines in management of COVID-19. The LOC must facilitate COVID-19 testing for delegations when it is required to have a negative test for return to their country. The competition will be organized considering the safety of participants and current COVID instructions of Estonian Government and authoritative. For any policy update regarding the COVID-19 Travel Regulations in Estonia, the LOC will keep all delegations and interested parties informed.		

	In addition, the LOC will distribute information regarding gymnasts' safeguarding plan.		
VISA	Please verify immediately with your travel agent or the Estonian Embassy or Consulate in your country if a visa is required for your travel to Estonia. The Organizing Committee will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before January 27, 2024, to the LOC http://rgform.eu/event.php?id prop=5280. The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member, as well as the city the visa application support letter must be sent to.		
INSURANCE	The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness (including COVID-19), repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and repatriation for all the members of their Delegation. Basic insurance (sickness, accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance. Please also refer to https://www.gymnastics.sport/site/pages/medical-insurance.php for additional information regarding the FIG IMSSA insurance for Athletes and Judges. If the note has not been sent in advance to the LOC (which is strongly recommended), the LOC will verify the insurance coverage upon arrival of the delegation members (e.g., cover note or photocopy of the valid policy). The insurance must be valid at least starting from the arrival day of the delegation and must last for the delegations' entire stay. Delegation members with insufficient insurance coverage must inform the LOC in advance. The LOC will subsequently offer insurance coverage at the Federations own charge as follows: 50€ per person.		
SAFEGUARDING	From the official event day of arrival until the official day of departure, participants (gymnasts, coaches, judges and any other delegation members) have the possibility to contact by phone or e-mail the LOC Safeguarding Officer in case of harassment and abuse of any type or if they are worried and do not feel comfortable. The information regarding the LOC Safeguarding Officer will be communicated upon arrival of the delegations on site. In addition, posters of the "10 Golden Rules of Gymnastics", the FIG campaign to raise awareness about youth protection in Gymnastics, will have to be displayed in several locations, including training and warm-up halls and public zones.		
INTERNATIONAL TRANSPORTATION	The invited participating federations must pay the international travel costs of their delegation members. The Travel Schedule Form must be returned to the OC – ONLINE: http://rgform.eu/event.php?id_prop=5280 by January 27, 2024. If delegations will send travel plan later than January 27, 2024, then the local transportation from the airport won't be guaranteed. Local Transportation will be provided only for the Delegation members who booked their accommodation through the Organizing Committee.		

LOCAL TRANSPORTATION

Free local transportation for all accredited delegation members:

- from Tallinn International Airport, Tallinn Railway Station or Tallinn Harbor to the hotel and back
- from the hotels to the Competition Venue and vice-versa (shuttle busses)

Will be provided only for the Delegation members who booked their hotel accommodation through the Organizing Committee.

ACCOMMODATION AND MEALS

All delegations must stay in the official hotel of this event. The hotel rooms will be allocated on a "first-come, first-served" basis. The invited participating federations and clubs must pay for the accommodation expenses of their delegation members.

The prices charged for the hotel rooms will not exceed the usual hotel rates. While the Accommodation Form must be returned to the LOC ONLINE – http://rgform.eu/event.php?id_prop=5280 by January 27, 2024, at the very latest, the Hotel rooms will be allocated on a "first come, first serve" basis.
